The property beside the 911 building is being considered for rezoning by the town for the current owner. The Executive Director is going to check the covenants on the Industrial Park to see if the change is allowed.

The property behind the government center is being considered for rezoning from commercial to residential. The IDA board has no objections or concerns regarding the change.

The USDA grant for the revolving loan fund has been received.

The VEDP & Job Grant has been approved for the preliminary engineering work for the Moss III Industrial site.
